## ENCUMBRANCE MANAGEMENT

<b>Automatic Budget Checks and Balances</b>	<p>Enter tolerance levels for specific amounts over budget, conduct mass encumbrance approvals, reserve encumbrances, and require passwords for approvals that are over specified amounts.</p>
<b>Budget Alerts</b>	<p>Set up automatic messages to alert designated managers when a purchase order will result in over-commitment of a certain line item.</p>
<b>Accurate Forecasting</b>	<p>Help ensure that funds will be available when critical payments become due.</p>
<b>Tracking Capabilities</b>	<p>Upon entering transactions, you can immediately trace numbers. You can also track encumbrances on an annual, period, or year-to-date level, with summary or detailed information easily available across a range of accounts.</p>
<b>Purchase Order Approvals Integration</b>	<p>Approve purchase orders based on the purchase amount, validate the budget available, and encumber purchases for reporting purposes. Provide an additional encumbrance authorization for those purchase order lines that exceed available funds.</p>
<b>Multiple Inquiry Options</b>	<p>Conduct a wide range of inquiries on encumbrances at the summary or detail level, across a range of accounts, or on current or historical encumbrances. Query and drill down by individual purchase order number and search by more detailed criteria, including quantity ordered, quantity cancelled, and unit cost.</p>
<b>Flexible Reporting Capabilities</b>	<p>Support your organization's unique work requirements with the freedom to view or print encumbrances from any day, week, or year in the past, as well as audit reports that show changes in value based on transactions.</p>
<b>Year-End Encumbrance Transfer</b>	<p>Transfer remaining encumbrance balances to the next fiscal year and optionally increase the next year's budget by the amount of the transferred encumbrance to accurately reflect allocated budget dollars.</p>
<b>Encumbrance Management and Analytical Accounting Integration</b>	<p>Provide not-for-profit and public sector organizations with the ability to encumber funds against an Analytical Accounting budget or a grant budget that is defined within Analytical Accounting instead of within a General Ledger budget.</p>
<b>Encumbrance Management Summary and Detail Inquiry</b>	<p>Supply an additional level of detail by including pre-budget (amounts on unapproved purchase orders), pre-encumbered (amounts from purchase order lines that exceed budget), and encumbered amounts (amounts for good or services that have not yet been received) as separate totals. This helps users get a true picture of available budget based on the various encumbrances. Also, the multi-year budgeting capability now enables you to view the inquiry data by budget or year.</p>
